1. Areas of agreements

- ii) The primary objective of this memorandum is to create means of cooperative efforts between the two institutions to create social bond.
- iii) Besides this both the sides will consult together upon any matter relating to the terms of this MoU, and will endeavor jointly in a spirit of co-operation and mutual trusts to resolve any difficulties or misunderstandings which may arise.
- iv) The MoU may be amended by mutual written consent of both the sides.

2. Effective date and duration;

- i) By written mutual consent, this agreement shall go into effect from the signed date by both the parties.
- ii) The agreement will remain in effect for Three years and may be renewed subject to renegotiation six months prior to the date of expiration.
